

REGULAR MEETING OF THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF GLUCKSTADT, MISSISSIPPI

Minutes

1. Call Meeting to Order and Roll Call

The Mayor called the December 13, 2022 meeting of the Mayor and Board of Aldermen to order.

2. Opening Prayer and Pledge of Allegiance

E) Request to Contribute to Gluckstadt Madison Business Alliance, Chamber of Commerce (Advertising Budget, \$2500.00)

The Mayor requested a motion to approve an advertising payment in the amount of \$2500.00 to the City's Chamber of Commerce, the Gluckstadt Madison Business Alliance, for promotion of the city and advertising of future city events.

Motion made by Alderman Powell, Seconded by Alderwoman Williams. Voting Yea: Alderman Powell, Alderman Taylor, Alderwoman Williams, Alderwoman Warfield Bates, Alderman Slay.

The Mayor declared the motion carried.

The Mayor declared the motion carried.

10. Police Chief, Police Department & Municipal Court Matters (Chief Wendell Watts)

A) General Update, Police Department - Chief Watts

The Chief of Police provided an update on law enforcement matters.

11. Public Comment

12. Closed Session to Determine Need for Executive Session

The Board considered entering into closed session to determine whether to go into Executive Session.

Motion made by Alderman Slay, Seconded by Alderwoman Williams.

Voting Yea: Alderman Powell, Alderman Taylor, Alderwoman Williams, Alderwoman Warfield Bates, Alderman Slay.

The Mayor declared the motion carried.

The Board then considered entering into Executive Session.

Motion made by Alderwoman Bates to enter into executive session for the transaction of business related to the police department land purchase and personnel matters related to the city clerk's department staffing (job performance and increase in compensation of Deputy City Clerk). Seconded by Alderman Powell.

Voting Yea: Alderman Powell, Alderman Taylor, Alderwoman Williams, Alderwoman Warfield Bates, Alderman Slay.

The Mayor declared the motion carried.

The Board entered Executive Session. A public announcement was made that the Board had entered into Executive Session for the transaction of business related to the police department land purchase and personnel matters related to the city clerk's department staffing (job performance and increase in compensation of Deputy City Clerk).

A) Police Department & Municipal Court Land Purchase, Execution of Closing Contract

After board discussion of the closing process on the police station land contract, the Mayor requested a motion to approve the execution of the closing contract on the land purchase (purchase of one acre of property for the purpose of building a police station and municipal court at purchase price of \$315, 810.00) and accept the donation of a second acre of land, generously donated developer, Anthony Morrison.

Motion made by Alderman Taylor to authorize the Mayor to execute the one-acre land purchase contract for the purposes of building a police station and municipal court at a purchase price of \$315,810.00 and accept the donation of a second acre of land, generously donated developer, Anthony Morrison. Seconded by Alderman Powell.

Voting Yea: Alderman Powell, Alderman Taylor, Alderwoman Williams, Alderwoman Warfield Bates, Alderman Slay.

The Mayor declared the motion carried.

A) City Clerk's Request for Mid-Year Increase in Compensation for Deputy City Clerk, Due to Workload and Job Performance

After board discussion of the Deputy City Clerk's job duties and workload, and his starting alary of \$48,000.00, the City Clerk requested board approval to increase the Deputy City Clerk's salary to \$54,000.00, effective upon reaching his 6 month work anniversary on December 20,

2022 (placed on subsequent pay period); and an additional increase to \$58,000.00 upon reaching his one year employment anniversary on June 20th, 2023.

Motion made by Alderman Taylor to authorize increase of Deputy City Clerk's salary from \$48,000.00 annually to \$54,000.00, upon reaching his six month employment anniversary of December 20, 2022, with an additional increase to \$58,000.00 effective upon his one year employment anniversary of June 20, 2023.

Voting Yea: Alderman Powell, Alderman Taylor, Alderwoman Williams, Alderwoman Warfield Bates, Alderman Slay.

The Mayor declared the motion carried.

Within Executive Session, a motion was made by Alderman Slay to leave Executive Session and reenter Open Session. Seconded by Alderman Taylor.

The Executive Session ended. A public announcement was made as to the actions taken by the Board; the Board approved authorization of closing on a one-acre land purchase contract for the build out of the Police Station and Municipal Court at \$315, 810.00 and acceptance of a donation of an additional acre of land by the developer. Additionally, the Board approved an increase in salary for the Deputy Clerk from \$48,000.00 annually to \$54,000.00, upon reaching his six month employment anniversary of December 20, 2022, with an additional increase to \$58,000.00 effective upon his one year employment anniversary of June 20, 2023.

13. Adjourn

There being no further business before the Board of Aldermen, the Mayor requested a motion to adjourn.
