NOTICE OF A TAX INCREASE AND A PUBLIC HEARING ON THE PROPOSED BUDGET AND PROPOSED TAX LEVIES FOR THE CITY OF GLUCKSTADT, MISSISSIPPI

The City of Gluckstadt will hold a public hearing on a proposed ad valorem tax revenue increase for fiscal year 2021-2022 and on its proposed budget and proposed tax levies for fiscal year 2021-2022 at 6 p.m. on September 7, 2021, at Germantown High School, in the Cafetorium, 409 Calhoun Station Pkwy, Gluckstadt, MS 39110.

The City of Gluckstadt is now operating with projected total budget revenue of \$360,500. Zero (0) % or \$0 of such revenue is obtained through ad valorem taxes. For next fiscal year, the proposed budget has total projected revenue of \$3,584,027. Of that amount, 37.97% or \$1,360,793 is proposed to be financed through a total ad valorem tax levy.

For next fiscal year, the City of Gluckstadt plans to increase your ad valorem tax millage rate by 12 mills from 0 mills to 12 mills. This increase means that you will pay more in ad valorem taxes on your home, automobile tag, utilities, business fixtures and equipment and rental real property.

Any citizen of City of Gluckstadt is invited to attend this public hearing on the proposed ad valorem tax increase, and will be allowed to speak for a reasonable amount of time and offer tangible evidence before any vote is taken. The proposed 2021-22 budget is available for inspection at 113 Dees Dr., Suite C, Gluckstadt, MS 39110
