# MINUTES OF THE REGULAR PUBLIC MEETING OF THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF GLUCKSTADT, MISSISSIPPI TUESDAY, JULY 12, 2022, 6:00 P.M. CITY HALL, 343 DISTRIBUTION DRIVE, GLUCKSTADT, MISSISSIPPI

The Mayor called the July 12, 2022, meeting of the Mayor and Board of Aldermen to order.

#### 1. Call Meeting to Order and Roll Call.

## A) Consideration: Purchase of Equipment and Safety Supplies for General City Maintenance / Public Works Projects (Off-Duty Firemen)

The Mayor stated that Alderman Powell and Alderman Slay requested this matter be placed on the agenda for consideration and asked if all members of the board had read the proposed Amended Fireworks Ordinance. All board members indicated they had read it. Robbie Covington, owner of Robbie's Fireworks, spoke up from the audience and stated he had not read it (and City Attorney Mr. Scanlon also stated that counsel for Robbie's Fireworks had requested that evening via text message to be heard on the matter before a vote is taken on the amended fireworks ordinance). The Mayor asked if there was a motion to table the revised fireworks ordinance. Alderman Taylor made a motion to table the revised fireworks ordinance until the next meeting in August. The motion died for a lack of a second. The Mayor then

requested a motion to adopt the revised fireworks ordinance. (Exhibit "F"). Alderman Powell made the motion to adopt the revised fireworks ordinance (replacement of Ordinance No. 2022-04, previously adopted by the board on May 10, 2022). A) Discussion and Consideration: Regulating Distance Between Future Locations of Package Liquor Stores and Hours of Operation (Request: Alderwoman Williams)

The Mayor opened the floor for members of the public to address the board and speak in favor of or in opposition to the proposed change in the zoning ordinance.

Ms. Sonia Bedi, owner of Germantown Wine & Spirits, spoke in favor of regulating the distance between liquor and/or package stores.

Alderwoman Williams requested the City Attorneys provide an amended draft of the zoning ordinance reflecting her proposed requests of a 3,000 ft. distance requirement and regulation of hours of operation.

B) Discussion and Consideration of Quote for City Hall Renovation & New Information Provided by Property Owner Regarding Revision to City Hall Lease (Temporary Police Department and Municipal Court)

The Mayor requested a motion to approve City Hall renovations by the property owner and the amendment to the lease to reflect the following: extension of the term of the lease one year (ending 8/31/26), with a new rent payment of \$8,292.00 beginning on September 1<sup>st</sup>, 2022, which will increase again to \$8,792.00, beginning September 1<sup>st</sup> of 2023. ## B) Discussion and Consideration of Approval: Financing of Five Dodge Durango Vehicles and Purchase of Equipment (Quotes)

The Mayor requested a motion to approve the quote for purchase of five (5) additional police vehicles (Dodge Durango PPVs, including the outfitting of necessary equipment such as light bars, sirens, etc.) at the state contract price of \$40,835.00; \$204,175.00 for all five (5). Police Officers. (Exhibit "J"). The motion was made by Alderwoman Williams, and seconded by Alderman Powell, and a vote was taken thereon as follows:

#### John Ramsey

The Mayor requested a motion to extend a formal offer of employment to John Ramsey for the position of Police Officer (Patrol Unit). Alderman Slay made a motion to hire Mr. Ramsey at \$36,000 annually, plus benefits to include PERS retirement contributions and 100% employee coverage of BCBS health insurance benefits. (Note: Mr. Ramsey declined health insurance benefits, as he already has a policy). The motion was seconded by Alderman Powell, and a vote was taken thereon as follows:

A public announcement was made that the Board had entered into Executive Session for transaction of business and discussion of personnel matters for the purpose of discussing the hiring of one (1) individual for the Police Department and to discuss the candidate's qualifications for the position, as well as the discussion of potential options for land purchase to build the Gluckstadt Police Department and Municipal Court.

## A) Request for Approval to Extend Offer of Employment to One (1) Candidate for the Position of Police Officer

Motion was made by Alderman Slay to extend conditional offers of employment, setting the annual salary for the position of police officer at \$36,000, plus benefits to include PERS retirement

and 100% employee coverage of BCBS health insurance benefits to one (1) candidate for Police Officer; Alderman Powell directed the Mayor and Chief of Police to provide an offer letter to the individual and note in the offer letters that the offer of employment was contingent upon successful passage of all background checks, drug testing, psychological testing and a polygraph examination, as required by the City Police Department. The motion was seconded by Alderman Slay and a vote was taken thereon as follows:
